

Ban of Netting in Portland Bay

Having lived in Portland overlooking the Portland Bay for 45 years, and having dived in the Bay throughout this period I totally support the banning of netting, having witnessed the enormous damage that was done by this netting when the Commercial Fisherman from Melbourne hammered the Bay with nets for weeks on end, which was totally against the " Gentleman ` s agreement " b/n. the local Commercial Fishermen and the Portland residents because they recognised the damage that netting did not only to the environment but to the Portland community as a whole

These include:

- Totally destroying the fish stock and the fish nursery, taking a reported 1.7 tonne of whiting in one day

Today, the result of the netting is that since it was done there are very few fish being caught by recreational fishers and the Bay environment has not recovered to this day

- Destroyed the **Leafy Sea Dragon colony** that lived throughout the Bay
- Whereas before the Commercial Netting took place we would regularly observe 40 -60 small boats on the Bay b/n Snapper Point and the Port enjoying the safety offered in the Bay and catching a few fish, today we see only 3-6 boats

The bay because of its safety as well as its proximate to the Boat Ramp is enjoyed by everybody particularly by Senior Citizens and by young families teaching their children the joyment of catching a couple of fish

- Obviously the lack of tourist of not catching a few fish has a long term economic effect as well on Portland

I fully support the draft of the proposed Portland Bay Commercial Fishery Notice 2025, that seeks to:

- * prohibiting the use of mesh nets, trawl nets and seine nets in specified waters of Portland Bay;
- * restricting the use of longlines in specified waters of Portland Bay;

As a signatory on the 1994 Code of Conduct between recreational anglers and commercial Fishers in Portland Bay, I think this agreement is fair and allows everyone to have access to this public resource.

This includes 85% of the population who buy their seafood caught by Commercial fishers.

This Fisheries Notice only allows access to Portland Bay to a small group of anglers with boats.

I don't think this is a fair way to share this resource.

Over the years this small group of boat owning anglers, have taken to social media to support their rights to the Bay. I do not think their opinions are backed by scientific evidence.

Part of their campaign has included threats aimed at commercial Fishers. This is hardly a healthy environment to operate a business.

The V.F.A. says that it needs this Portland Bay Fishery Notice to stop any conflict between commercial and recreational fishers. The only conflict in the past has come from the recreational group. No commercial fisherman has ever denied them access to this resource.

The V.F.A. as part of the Victorian Public Service is not representing the majority of the Victorian population. They are only giving access to a minority group.

These recreation anglers will not be happy until Commercial fishing is banned from all Victorian State waters.


The V.F.A. has never considered the financial cost of setting up a fishing business. This includes all fishing gear, an A.M.S.A. surveyed boat, relevant training and tickets for skippers and crew.

One signature makes our business unviable overnight. We have been shut out of Portland Bay for the last two years, by the past Portland bay Fisheries Notice. It has been made illegal by the Victorian Supreme court this year.
