

### **Management Plan Update**




- New management plan declared by the Minister on 27 October 2024

- New harvest strategy will formally apply in stock assessment








#### **Total Weight Harvested**




Percentage of TACC

Size Frequency Distribution






Carapace Length Size Class (cm)
