### FISHERIES (REVOCATION) NOTICE 2020

**1. Title**

This notice may be cited as the Fisheries (Revocation) Notice 2020.

**2. Objective**

The objective of this notice is to revoke the Fisheries Notices specified in the Schedule, which will become redundant when the Fisheries Regulations 2019 commence operation on 1 February 2020.

**3. Authorising provisions**

This notice is made under section 152 of the **Fisheries Act 1995** and section 27 of the **Interpretation of Legislation Act 1984**.

**4. Commencement**

This notice comes into operation on 1 February 2020.

**5. Revocation of Fisheries Notices**

The Fisheries Notices specified in the Schedule are revoked.

**Note**

Section 152(5) of the **Fisheries Act 1995** provides that, unless sooner revoked, this notice is revoked by virtue of that section on the day which is 12 months after the date on which it came into operation.
