#### **Foreword**

# A report to each House of Parliament on the disbursement of Recreational Fishing Licence Revenue from the Recreational Fishing Licence Trust Account, 2022-23

Every year the Victorian Government provides revenue from the sale of recreational fishing licences to a range of programs and projects that make substantial improvements to recreational fishing in Victoria.

As the Chief Executive Officer, Victorian Fisheries Authority, I recognise the significant contribution that recreational fishing makes to the State's economy and the social wellbeing it brings to all those who participate in this popular activity.

I would like to thank the Recreational Fishing Licence Trust Advisory Committee, who have continued to provide valuable and timely advice on how RFL funds should be disbursed through the Recreational Fishing Grants Program.

The 2022-23 round of the Large Grants Program will see over \$1,233,563 allocated to 10 new projects. These projects include a major upgrade of the Gunbower Weir fishway, research and development into the captive breeding of Macquarie perch, replenishment of the recreational fishing reefs around Port Phillip Bay, increased habitat and access at Kennington Reservoir, an upgrade of the bore pump at Lake Karkarook which maintains water levels, a multilingual fishing information campaign on radio across Melbourne, and further habitat restoration in the Gippsland Lakes.

A further \$403,692 was allocated via the Commissioning Grants Program; \$276,512 to produce a range of popular education and communication products that assist recreational anglers to understand and comply with fishing regulations, and \$127,180 for the monitoring of recreational fisheries at key locations in Port Phillip Bay, Western Port, the Gippsland Lakes, Corner Inlet, and the coastal Lakes Entrance fishery.

In addition, five Intermediate Grant applications were also approved. This included a grant of \$50,000 to the Lake Purrumbete Angling Club to improve access at Lake Purrumbete, and a grant of \$50,000 to Ouyen Inc. to complete the floating walkway which now spans Ouyen Lake and provides land-based fishers with access to deeper and more productive water.

The Small Grants Program saw over \$32,987 provided to angling clubs to run events and activities. This program has funded over 420 projects worth more than \$1 million since its inception in 2010.

During 2022-23, Recreational Fishing Licence Trust Account funds were also committed or disbursed to fund:

- increased fish stocking into hundreds of lakes and rivers, including iconic native species such as Murray cod, golden perch and Australian bass, and the highly sought brown trout, rainbow trout and chinook salmon.
- the deployment of Fisheries Officers to boost enforcement and education and protect our valuable fisheries.
- programs and projects to get more Victorians fishing, which has included even more fish stocking as well as the staging of the Hooked on Festivals at Portland, Portarlington and Lakes Entrance and the Vic Fish Kids events at various locations.
- VRFish, to provide advice to the Victorian Government about the broad range of recreational fishers' views on the management of the State's fisheries resources.
- the Victorian Fishcare program, which delivers responsible fishing education and events to the community.
- · projects approved through previous rounds of the Recreational Fishing Grants Program; and
- the costs incurred in the administration of the Recreational Fishing Licence and Grants Program.

I'm sure that all recreational fishers would be very happy to know that their licence fees go towards increased fish stocking, better facilities, improved habitat, fisheries research, and more enforcement and education. It goes a long way towards keeping recreational fishing in Victoria in great shape and preserving it for future generations to enjoy.

I have pleasure in providing to each House of Parliament this report on the receipts and disbursements from the Recreational Fishing Licence Trust Account for 2022-23.

### Fisheries Act 1995

Pursuant to Section 151B(4) of the *Fisheries Act 1995*, the responsible Minister must cause a report on how amounts paid into the Recreational Fishing Licence (RFL) Trust Account were disbursed:

- (a) to be prepared by 1 October each year; and
- (b) to be laid before each House of Parliament on or before the seventh sitting day of that House after the report has been prepared.

For the information of Honourable Members, the RFL Trust Account came into effect on 1 April 2001.

The role of the Victorian Fisheries Authority (VFA) is to administer the Recreational Fishing Licence Program and manage the amounts determined by the Minister for Outdoor Recreation for the purpose of improving recreational fishing.

The VFA also administers the Recreational Fishing Grants Program and provides support to the Recreational Fishing Licence Trust Advisory Committee which provides advice to the Minister for Outdoor Recreation on how funds from the sale of licences should be spent to improve recreational fishing in Victoria.

The 2022-23 financial year is the twenty second full year of the RFL Trust Account's operation.

The Victorian Auditor-General's Office has audited the receipts received, and disbursements made from the RFL Trust Account in 2022-23.

## **Enforcement & Education**

In 2022-23, RFL Trust Account receipts contributed \$2,024,916 to the VFA's compliance budget.

RFL Trust Account receipts, when added to ongoing recurrent funding of fisheries compliance (education and enforcement) activities, contributes substantially to the delivery of recreational fisheries compliance services in Victorian coastal and inland locations.

Fisheries Officers have continued to have good contact with recreational fishers in the field during the last year. Table 1 summarises yearly totals for contacts in the recreational fishing sector. The work is divided into categories based on species, locations, or other activities. Over 47,232 total contacts were made with recreational fishers (including Marine Safety) by Fisheries Officers during the reporting period. Compliance contacts (not including Marine Safety) with Fisheries Officers totalled over 40,921 with Table 1 showing the number of offenders, verbal warnings, official warnings, infringement notices, and briefs of evidence for the year.

In addition, Fisheries officers conducted 6,310 Transport Safety Victoria inspections resulting in 1,266 offenders, 568 verbal warnings, 728 official warnings, 442 Infringement Notices and 0 briefs of evidence.

Fisheries Officers also attended 73 recreational fishing related shows, forums, clinics, and events (including angling club meetings) for over 6165 contacts.

All Fisheries Officers provide services to the recreational fishing sector and interact with recreational fishers through:

- contact with recreational fishers in the field.
- attending angling club meetings.
- attending recreational fishing-related shows, family fishing events, forums, and clinics.
- · attending fish stocking events.
- liaising with grant recipients regarding the successful completion of infrastructure projects under the annual Recreational Fishing Grants Program (Large Grants).
- · advising fisheries management on issues relating to recreational fishing.
- assisting Fisheries Management, Policy, Science and Licencing Branch on matters relating to recreational fishing.
- responding to recreational fishing issues raised from the 13FISH Offence Reporting Line.
- producing recreational fishing-related media releases/distributing booklets and pamphlets.
- investigating recreational fishing-related offences and prosecuting where necessary.
- collecting intelligence related to recreational fishing offences.
- participating in recreational fishing-related educational activities with school groups and the broader recreational fishing community; and
- engaging with culturally and linguistically diverse communities.

The VFA in conjunction with the recreational fishing community strives to achieve high levels of voluntary compliance amongst recreational fishers. By working collaboratively and by continuing to promote responsible and ethical fishing, we are better positioned to ensure both fish for now and fish for the future.

## Fish Production and Stocking

In 2022-23, RFL Trust Account receipts contributed \$1,036,672 to the VFA's fish production and stocking budget. This includes \$1,001,672 of the base amount (approved by the Recreational Fishing Grants Working Group in May 2012, ongoing) to support fish production and stocking from Snobs Creek and Arcadia, and \$35,000 from the RFL component of the Go Fishing Victoria initiative. These funds along with state government funds enabled the VFA to stock over 8 million fish in 2022-23, This was short of our 10 million target due to low availability of fish during the 2022-23 production season. The VFA is on track to stock 10 million fish over the 2023-24 year.

RFL Trust Account receipts, when added to state government funding of fish stocking and production activities, contributes significantly to the delivery of recreational fisheries state-wide stocking program.

The combined funds are used to operate the fish hatchery at Snobs Creek, meet costs associated with the delivery of fish across the state and for the purchase of additional fish.

In 2022-23 the VFA (Snobs Creek and Arcadia) grew 1,200,400 native fish and 1,311,874 salmonid fish that were stocked into public waters. In addition to these fish the VFA purchased 5,503,573 mixed species of fish that were picked up and delivered to various locations across the state.

During 2022-23 VFA staff associated with the production and delivery of fish carried out activities such as:

- · management of broodstock across all species.
- · harvesting of eggs from all species.
- · feeding fish of all ages.
- · careful movement of fish as they develop.
- · animal health monitoring and management; and
- our stocking vehicles travelled 218,180 km's which took 568 person days to undertake.

The VFA works closely with anglers and other key stakeholders to coordinate the successful breeding and delivery of fish across the state.

## Go Fishing Victoria

In 2022-23, RFL Trust Account receipts contributed \$836,677 towards the VFA's implementation of the Go Fishing Victoria initiative to grow participation and provide more fishing opportunities.

RFL Trust Account receipts, when added to state government funding, contribute significantly to the delivery of the Go Fishing Victoria initiative. The State Government has extended its commitment with Phase 3 of the Go Fishing Victoria initiative, which will see a further \$96 million invested to grow participation and fishing opportunities around the state.

The RFL investment has contributed significantly to several aspects of the plan including improved access, fish stocking, events and engagement, the Go Fish Vic app, and the rock lobster tagging program. A summary of achievements in each of those areas is presented below.


#### **Improved Access for Anglers**

A total of \$134,766 has been spent on improving infrastructure and access in 2022-23. Projects which received funding included: installation and maintenance of fish aggregating devices offshore from Torquay, restoration of riverside tracks on the Loddon River by Loddon Plains Landcare Network to allow public access to fishing sites around the Serpentine Weir area, maintenance of the Lake Banimboola fishing area by the Dartmouth Progress Association, works undertaken by GWM Water to provide a reliable water supply to Nhill Lake to create a new recreational fishing lake, and a survey of the site for a future shellfish reef restoration project by Albert Park Yacht & Angling Club.

#### **Fish Stocking**

The 2022-23 season has been a very challenging period for the VFA's native fish stocking program. The unseasonal cold weather in November/December 2022 resulted in a reduced supply of Murray cod eggs and larvae at the Snobs Creek hatchery.

This unusual cold weather, including snow in the late spring, also adversely affected the breeding and production of fish across all farms involved in meeting the VFA's supply and stocking targets, particularly with golden perch. As a result, the VFA was only able to stock just over 8 million fish, which was well below the target of 10 million fish. The VFA is now on target to reach the 10 million stocking target in 2023-24.



#### **Events and Engagement**

The 2022-23 period saw the return of a packed event calendar, with a Go Fishing Victoria RFL investment of \$393,398. There were many highlights including:

- **Ultimate Fishing Expo** 7,800 people attended this free public event at the Melbourne Exhibition Centre, showcasing stalls and presentations from fishing experts such as Robson Green and Patrick Dangerfield.
- World Recreational Fishing Conference The world's largest fishing conference was hosted by the VFA.
   The 380 delegates that attended were treated to presentations from experts across Australia and overseas.
- Hooked on events Events were held in Portland, Portarlington and Lakes Entrance to showcase celebrations
  of seafood in key tourism destinations, attracting between 2,000 and 5,000 people at each event.
- **Trout Season Opening** events The Ballarat and Goulburn Fishing Festivals were staged on the same day to celebrate the trout season opening and attracted 2,000 and 900 people respectively.
- **Vic Fish Kids** clinics were held at Lilydale Lake, Seymour, Casey Fields, Lake Fyans and Churchill, in partnership with local communities, VFA Ambassadors and Fishcare volunteers.
- Local forums a series of community networking events were presented by the VFA at Torquay, Wodonga, Portland, Epping, Mitcham, and Port Albert.
- AccessAbility Lilydale was delivered as in conjunction with Fishcare and BBV, to provide a bespoke
  experience for 40 disabled fishers.
- **Snobs Creek Open Day** attracted 700 people with guided tours and a focus on the soon to be built Conservation Hatchery, in conjunction with the Arthur Rylah Institute.

#### Women in Recreational Fishing and Boating (WIRFAB) Network

The Women in Recreational Fishing (WIRF) network expanded in 2023 to include boating and create a more inclusive and empowering environment for women, embrace new challenges and celebrate the passion for fishing and boating.

A new strategy has been developed to guide the network through to 2026, with objectives focusing on increasing participation and education, and community building and advocacy for female anglers and boaters. The WIRFAB website was launched and continues to build a collection of valuable materials to enhance fishing and boating experiences.

The online community now has over 4,500 members, with over 300 women involved in the WIRFAB Locals community program. Over 30 women have participated in the WIRFAB Leadership Program, with five new leaders joining in 2023. WIRFAB leaders represented the VFA at the Ultimate Fishing Expo and International Women's Day saw 'learn to fish' clinics run at three different locations. Multiple community events were also run through the WIRFAB Locals program, including women's tackle nights, casting clinics and skills-based fishing sessions.

#### GoFishVic App

The GoFishVic app provides a novel way of empowering our valuable stakeholders in contributing to the overall management of our recreational fish stocks. The App harnesses the power of the citizen science concept to record recreational fishing (catch) data which in turn allows fisheries managers to make informed management decisions.

In 2023, the App underwent a significant operational restructure, with the appointment of a new and experienced App developer to help update and refine the Apps' functionality and useability. A working group has been established to help canvass ongoing stakeholder feedback on the App, as well as test new (appropriate) functionality prior to future release.

#### **Rock Lobster Tagging Program**

Following a successful three-year trial, rock lobster tagging was established as an ongoing program in 2020 and recognised its contribution to improving the accuracy of annual stock assessments and building the VFA's capacity to make management decisions to maintain a healthy and sustainable fishery into the future.

Following the initial tagging phase, the VFA streamlined the process for catch reporting by way of digital tags which removed the requirement for fishers to order, possess and affix plastic tags to their rock lobster catch.

The new reporting program has been embedded into the GoFishVic App and was expanded to include the ability to view weather reports, add photos, create groups, share catch details via social media, and view personal catch statistics.

The VFA is now working closely with the recreational fishing community to further improve the functionality of the app platform and simplifying the reporting process associated with the digital tagging program. This will ensure the long-term viability of the tagging program and enhance its role in the management of the Victorian Rock Lobster Fishery.

#### **Notes to the Financial Report**

These notes form part of and should be read in conjunction with the financial report of the Recreational Fishing Licence Trust Account.

#### Note 1 - Statement of Accounting Policies

Basis of preparation

This special purpose financial report has been prepared in accordance with the provisions of the Fisheries Act 1995.

The Recreational Fishing Licence Trust operates under section 151B of the *Fisheries Act 1995* to distribute revenue derived from the sale of Recreational Fishing Licences to projects that will further improve recreational fishing opportunities in Victoria, and to fund costs incurred in the administration of recreational fishing licences.

Funds received by the Trust include:

- all levies and fees in respect of recreational fishing licences.
- all income from the investment of funds within the Trust; and
- any other money authorised to be paid to the Trust by the Minister.

These are reported as receipts in the Financial Report.

Disbursements from the Trust include improvements to recreational fishing as determined and the costs incurred to administer the recreational fishing licences.

The report has been prepared on a cash basis to report on how levies and application fees received in respect of recreational fishing licences have been disbursed from the Trust Account.
