Im hearing solid rumours of a Proposal of 1 Trophy Sized Bream in the New Regulations.

We are totally against that proposal - Gippsland Anglers Fbook Group

Gippsland Lakes hasn't recovered its only been 3 years of the current Slot Limit 28 - 38cm was implemented

The recent Twin Rivers Comp Shows that Catch Rate is still Terrible less than 1 Bream per Angler as detailed in previous email

Im sure your own Catch records would also show similar results

Im sure Survey will also be a great insight

We agree with Bag limit Reduction, Total Possession Limit reduction, Slot Limit there all good, but strongly against the Trophy Sized Bream Idea.

Im not sure where this 1 Trophy Sized Bream Idea has came from , but its a Terrible Idea, I heard David Kramer mention it on his Radio show before I was advised of this proposal.

#### 1 TROPHY BREAM

We need those breeding Bream Stocks in our System to Help it recover,

We all know that Large Bream normally School Together, so when you catch 1 Trophy Bream theres Normally more about, its not like there a

We Have Legal Limits on many species le: FLATHEAD Bag Limit Slot Limit without a Trophy Fish . why does Bream need a Trophy Size in the Regulations ?.

III be awaiting more feedback from the VFA before I become more vocal about this proposal




